

Training and Services Agreement

The owner of the above horse and Trowbridge's Ltd. Agree to the following:

1. Owner agrees that Trowbridge's Ltd. will provide _____ service at the rate of _____ per month. Fees pertaining are those on the current fee schedule. Fees are due and payable on receipt of invoice, with services billed prior to the beginning of the month of service rendered.
2. Trowbridge's Ltd. agrees to advise owner, as soon as practically possible, of any illness or injury to the horse. Trowbridge's Ltd. is authorized to have their veterinarian, dentist, farrier, etc., treat horse within reason if needed, without consent of owner, with owner liable for the cost of said service.
3. It is agreed that Trowbridge's Ltd., its owners, trainers, agents, apprentices, veterinarians, dentists, and farriers shall not be held liable for any injury, disability or death of any horse in its continuous care and control (whether on or off premises) except for gross negligence or willful misconduct by said agents.
4. Owner is liable for any damage to persons or property caused by the owner's horse, and agrees to defend Trowbridge's Ltd. in any legal action relating to horses' actions.
5. In the event that the horse is sold while at Trowbridge's Ltd., owner shall pay Trowbridge's Ltd. a 15% commission on the sales price, regardless of how the purchaser was identified or the sale transpired. Commission is due in full upon receipt of down payment.
6. Any owner leaving Trowbridge's Ltd. will settle all indebtedness to Trowbridge's Ltd., and their vendors, including, but not limited to farrier, veterinarian, and transporters. **No horse will be allowed to leave before all accounts are paid in full. There are no exceptions to this policy.**
7. Any horse leaving Trowbridge's Ltd. care must give a 7 day advanced notice. Horses leaving from horse shows must give 7 days notice prior to departure for the show. This enables Trowbridge's Ltd to provide final accounting for all vendors and proper travel documentation for said horse. **There are no exceptions to this policy.**
8. Owner agrees that Trowbridge's Ltd. has a right to lien for unpaid services, and has the right to retain horse until all bills are paid in full. In the event that Trowbridge's Ltd. exercises its right of lien for unpaid services, this agreement shall constitute a bill of sale that, together with an affidavit setting forth the facts of the default and Trowbridge's Ltd. compliance with the foreclosure procedures of the State of Connecticut, will authorize transfer application from any breed organization applicable to said horse. Owner shall reimburse Trowbridge's Ltd. for all costs, fees, and expenses, including reasonable attorney's fees incurred by Trowbridge's Ltd. in performing it's obligations or enforcing it's rights under this agreement.
9. All breeding clients are responsible for their own stallion or mare permits and all paperwork filed with the Registries.
